Letter from the President of EURALEX

Dear Members,

With the congress comes our general meeting, with elections for the board and officers of our association. In order to optimise the procedures we are seeking a wide participation. It is therefore important that the voting procedure be respected.

The board is the management council of the association, it is re-elected every two years. The number of board members is limited as board membership generates costs. There are ordinary members and office holders, all are expected to take on active roles. All the board members, ordinary and office holders, are directly elected by the general assembly.

One of the strengths of EURALEX is the constant renewal of the board, a renewal that maintains a sense of continuity. The President can only serve one two-year term. Thus, the current President remains on the board as an ex-officio Past President and, traditionally, the Vice President becomes President. The other office holders may stay as they are, but the Secretary

Treasurer has usually been assistant before so as to understand the accounting procedures. The Vice President is also generally an existing board member. The congress organiser, *ex officio* during the two hard years of planning, usually stands to rejoin the board. In recent years, we have endeavoured to have future congress organisers on the board so as to have a four-year period of build-up to an event. This system of gradual evolution ensures continuity, but it is also only a tradition, any member is free to stand for these positions.

Candidates for the board must be fully paid up EURALEX members by January 1 of the year they are running for the Board. Members running for the Executive Board must send in their candidacy midday Wednesday of the congress week with a proposer and seconder who are members as of January 1 of the year they are proposing. If in doubt, it is better to consult the Secretary Treasurer. Candidates must provide a brief (200-word biography) to the Secretary Treasurer by noon of the congress Wednesday. Candidates will be announced by Thursday 9 a.m. as the General Assembly will take place on Thursday. This procedure will make it easier for members to know who is running. We do wish to ensure the widest publicity as to who board members are and as to who proposes them to join the board.

The changes in subscription possibilities announced in the last newsletter are part of this process of maintaining the impetus in a changing world. We need young members to join and participate. This is why we are making clearer voting procedures.

The General Assembly itself will follow the usual pattern. The minutes of the previous meeting and the agenda being published in advance. If members wish to propose motions, then ideally these will be communicated before the meeting, preferably by Wednesday midday.

During the last meeting of the board, in Oslo in 2011, a number of proposals were put forward to improve the organisation of general assemblies. These include:

- (1) Access to accounts summary prior to General Assembly.
- (2) The provisional agenda for the meeting will be in the congress bag.
- (3) The Board will ask for 2 volunteers to count votes.

In addition to the clarified procedures, the board will appoint a subcommittee to write guidelines for the General Assembly. A general assembly is not just an administrative meeting, but an opportunity to participate in deciding the future orientations of the association.

Looking forward to seeing you in Oslo.

Afrilex: 3 – 5 July 2012 – Call for Papers

Papers on any aspect of lexicography or terminology are welcome. All papers will be adjudicated. Prospective presenters are to submit abstracts to reach AFRILEX before **31 March 2012**. Abstracts must be between 600 and 800 words long for adjudicators to make informed judgements on the central argument of the paper, especially given that conference proceedings are not published. Abstracts should contain the following elements: a central argument,

how the study was conducted and some (preliminary) conclusions. Papers that do not comply with these requirements will unfortunately be rejected.

Receipt of abstracts will be acknowledged and feedback will be given to authors as soon as it is received back from the adjudicators. Abstracts of accepted papers will be distributed during the conference. MS PowerPoint presentation facilities will be available. As a backup, presenters will be asked to e-mail their slide show ahead of the conference.

Please note: It is compulsory for presenters of papers, workshops and special sessions to register in advance (i.e. before 1 June 2012).
